

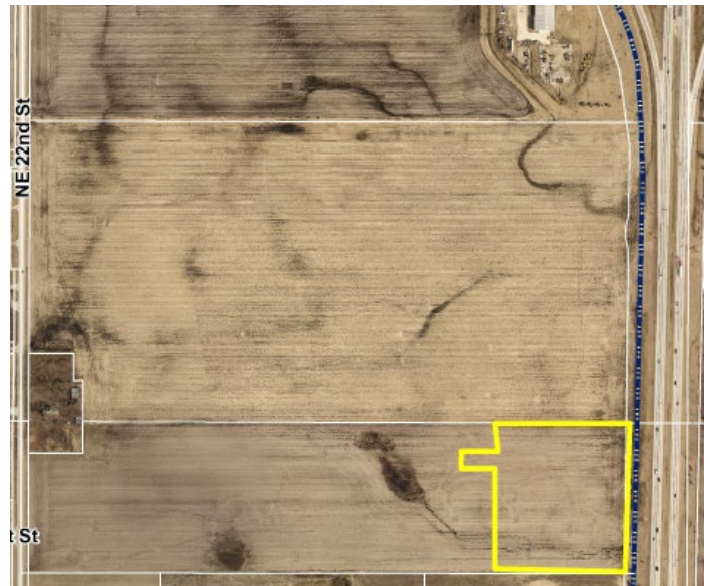
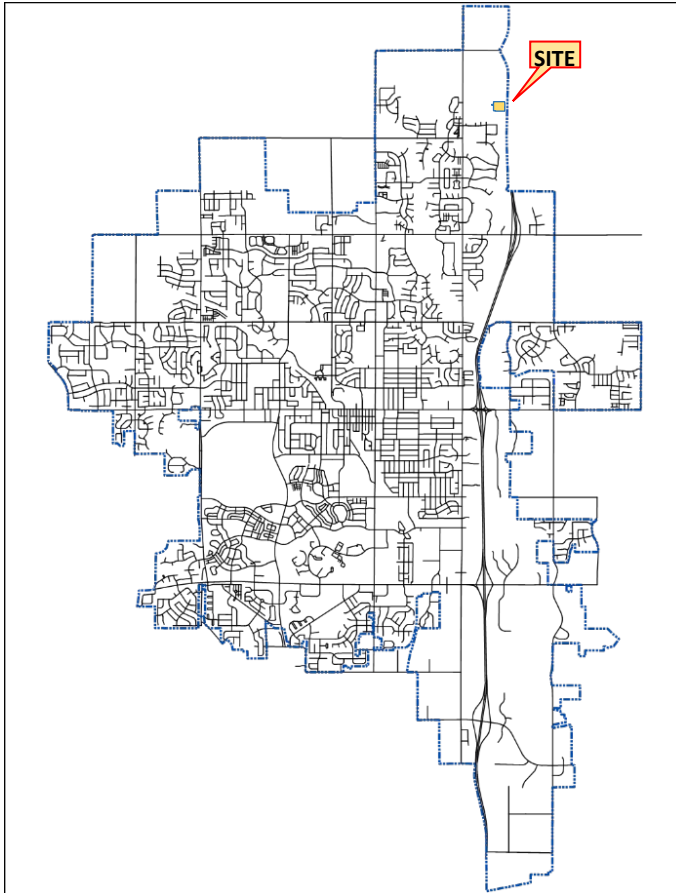

**RESOLUTION AMENDING THE ANKENY PLAN 2040 COMPREHENSIVE PLAN,
FIGURE 12.10, FUTURE LAND USE MAP, TO RECLASSIFY CERTAIN PROPERTY OWNED BY
HOPE K FARMS LLC, FROM LOW DENSITY TO HIGH DENSITY RESIDENTIAL, LUPA AREA #4**

WHEREAS, on the 16th day of April, 2024, the Plan and Zoning Commission of the City of Ankeny, Iowa, held a public hearing; and on the 7th day of May, 2024, recommended City Council approval of an amendment to The Ankeny Plan 2040 Comprehensive Plan, *Figure 12.10, Future Land Use Map*, to reclassify certain property owned by Hope K Farms LLC, from Low Density to High Density Residential (LUPA Area #4); and

WHEREAS, on the 3rd day of June, 2024, after due notice and hearing provided by law, and having heard and considered all comments for and against said amendment, the City Council of the City of Ankeny, Iowa, now deems it reasonable and appropriate to reclassify the following-described property:

LEGAL DESCRIPTION:

A PART OF THE NORTH ONE-QUARTER OF THE SOUTHWEST QUARTER OF SECTION 31, TOWNSHIP 81 NORTH, RANGE 23 WEST OF THE FIFTH PRINCIPAL MERIDIAN IN THE CITY OF ANKENY, POLK COUNTY, IOWA AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF KIMBERLEY CROSSING PLAT 1, AN OFFICIAL PLAT; THENCE SOUTH 89°48'58" WEST ALONG THE SOUTH LINE OF SAID NORTH ONE-QUARTER OF THE SOUTHWEST QUARTER, 41.07 FEET TO THE POINT OF BEGINNING; THENCE SOUTH 89°48'58" WEST ALONG SAID SOUTH LINE, 537.53 FEET; THENCE NORTH 00°07'14" EAST, 454.93 FEET; THENCE NORTH 89°52'46" WEST, 140.00 FEET; THENCE NORTH 00°07'14" EAST, 73.13 FEET; THENCE SOUTH 89°52'46" EAST, 140.00 FEET; THENCE NORTH 00°07'14" EAST, 127.06 FEET TO THE NORTH LINE OF SAID NORTH ONE-QUARTER OF THE SOUTHWEST QUARTER; THENCE SOUTH 89°51'46" EAST ALONG SAID NORTH LINE, 546.18 FEET TO THE WEST RIGHT-OF-WAY LINE OF INTERSTATE 35; THENCE SOUTH 00°52'53" WEST ALONG SAID WEST LINE, 652.17 FEET TO THE POINT OF BEGINNING AND CONTAINING 8.37 ACRES (364,396 SQUARE FEET).

LAYMAN'S DESCRIPTION:

Approximately 8.37-acres (+/-) located south of NE 126th Avenue and east of NE Delaware Avenue and west of Interstate 35.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Ankeny, Iowa:

1. That The Ankeny Plan 2040 Comprehensive Plan, *Figure 12.10, Future Land Use Map*, is hereby amended to reclassify the above-described property Low Density to High Density Residential (LUPA Area #4); and
2. That City staff is hereby authorized and directed to revise The Ankeny Plan 2040 Comprehensive Plan documents and maps necessary to reflect such change.
