Approval Process & Application Packet



Application process & submittal requirements:

Following complete submittal of the application, the easement vacation process generally takes 8 weeks and involves the publication of a notice of hearing, a public hearing by the City Council, three considerations of the ordinance vacating the easement and/or property, and publication of the approved ordinance. Any proposal to vacate a street, alley, portion thereof or any public grounds shall be referred by the Council to the Plan and Zoning Commission for its study and recommendation prior to further consideration by the Council.

This application must be accompanied by

- Letter of request
- Legal description and drawing
- Letters of authorization from utility companies
- \$360.00 fee (*includes administrative costs, cost of publication of notice and document recording*)
