

**Court Rules:** Ankeny Parks & Recreation has priority use of the courts for events and programming. Tournaments, leagues and private lessons are prohibited unless approved by Ankeny Parks & Recreation.

- Courts are for pickleball use only.
- Courts are open daily from dawn to 10:30 p.m.
- Court lighting is available from dusk until 10:30 p.m. Turn lights on with push button located on the west side of the restrooms.
- Play at your own risk, surfaces can be slippery.
- Proper athletic attire is required. Only athletic shoes with non-marking soles permitted.
- Snow removal from the courts is prohibited.
- No pulling, stretching or sitting on the nets.
- No animals, bikes, scooters, skateboards, rollerblades or skates allowed on the courts.
- No smoking, vaping, glass, food or drink allowed on the courts.
- No alcohol, drugs, abusive or foul language.
- All trash must be disposed of properly in trash receptacles.

**Game Play:**

- Players waiting to play should place their paddles in the paddle rack and must be present when the court becomes available. Double stacking of paddles is not allowed.
- When all pickleball courts are in use, play is rotational doubles.
  - All skill levels play together.
  - After one game, all players must exit the court and those next in line rotate in.
  - Games are played to 11, win by 2, cap of 15.
- An individual may not hold a court when players are waiting.
- Courts cannot be used for practice, drills or warm-up when there are players waiting.
- Nets are provided by Ankeny Parks & Recreation. Pickleball paddles, balls and other equipment are not provided.

**Reservations:**

- Paid rentals are allowed on courts 1-4 at a cost of \$10/hour per court.
- View rental schedule and reserve courts:
  - Online
  - On-site by scanning QR code posted at each court
- Reservations can be made up to seven (7) days in advance.
- There are no refunds for cancellations. Reservations impacted by inclement weather must contact the Parks & Recreation office within three (3) business days to request a Parks & Recreation credit.
- Courts may be rented in 1-hour increments and are limited to two hours per day per person.
- Reservations may be made up until the top of each hour, if available.
- Renter shall be permitted to use only the reserved court(s) during the time frame which has been rented, and must promptly leave the court(s) at the end of rental time.
- Additional services which are not normally provided by Ankeny Parks & Recreation, such as sound and lighting equipment, electrical and utility services, etc., must be furnished

solely by the Renter. Renter must obtain necessary permits that may be required in order to comply with all City of Ankeny codes.

**Tournaments and Special Event Rentals:**

- Paid reservations will be accepted in blocks of 4, 8 or 12 courts. Individual courts are not available.
- Payment of fees is due at the time of approved reservation.
- Rates are per court, per hour. An additional Complex Fee will be charged for all reservations three (3) hours or more. Fee will be based on number of hours and number of courts reserved.
- Special Event renter must be 18 years or older and remain on-site for the duration of the rental.
- Signs and/or banners may be posted on day of event only and must be removed at the end of rental period. Signs are not allowed in the right of way at any time.

**Damage:** Renter assumes full responsibility for damage caused to any facility during the rental and will be billed separately for all labor and materials. Should excessive facility maintenance or damages cause a delay or cancellation to a subsequent renter, Renter will be held accountable for any refund fees to the inconvenienced renter.
