Street Tree Planting Process

Any individual, business or corporation intending to plant a tree, shrub or other planting (except turf grass) upon a public right-of-way, shall have approval from the City of Ankeny (City) prior to any planting taking place. A Street Tree Planting Permit Application shall be submitted by the property owner and approved by the Public Works Department - Operations Division prior to the planting of the tree in the public right-of-way.

The process involved in obtaining a Street Tree Planting Permit is as follows:

1) Make a Plan:

- a) Select the desired species of tree for planting from the Allowed Street Trees list.
- b) To reduce loss from pests and disease, no more than 20% of one species of tree should be planted along a block.
- c) Determine the location of planting based on the City's planting requirements:
 - i) Size. Trees shall be a minimum of one and one-half (1-1/2) inches in diameter, measured six (6) inches above ground level.
 - ii) Planting Area and Alignment. In general, all trees planted in any public street right-of-way shall be planted in the parking area (green space) midway between the back of curb or edge of pavement and the front of the sidewalk. More specifically, where the distance between the back of curb and the sidewalk line is eight (8) feet or less, the tree shall be centered in the space. Where the distance between the back of curb and the sidewalk line is greater than 8 feet, trees shall be planted within four (4) feet of the sidewalk line.
 - iii) Separation. Trees shall be planted in such a manner as to avoid interference with, or obstruction of any improvements installed for public betterment such as public utilities, street signs, overhead utility lines, street lights, or utility poles. Trees shall be located a minimum of:
 - Fifteen (15) feet from a street sign, street light or traffic signal pole, fire hydrant, water valve, or utility access.
 - Fifty (50) feet from the back of curb or edge of pavement of the intersecting street (for corner lots at intersections) in 25, 30 and 35 mph zones. For greater speed limits, a site review will be needed.
 - Twenty (20) feet from the edge of driveways for all types of properties (residential, commercial, industrial or institutional properties).
 - iv) Spacing. Trees shall be planted at a maximum of one (1) tree for every 60 feet of frontage. Trees shall be spaced a minimum of twenty-five (25) feet from another tree, except along arterial and collector streets where buffering from noise is appropriate; in which case trees may be located so as to provide a continuous buffer. Smaller species of trees may be spaced to a minimum of twenty (20) feet when approved by the Public Works Department - Operations Division's Arborist.
 - v) Landscaping. Landscape block and landscape plantings are allowed in the right-of-way around trees with the understanding that it is at the abutting property owner's risk and any maintenance of the block and/or plantings or repair to the block and/or plantings caused by maintenance of street pavement, maintenance of public utilities, or the removal of street trees by City staff or contractor shall be the responsibility of and at the abutting property owner's expense.

- d) In the site plan sketch block provided in the application, indicate where any trees are to be planted and also sidewalks, streets, driveways, traffic signs, mailboxes, street lights, and other trees. Place a wood stake or lath in the location of where the tree(s) are intended to be planted.
- e) Call Iowa One Call at 1-800-292-8989 to locate the utilities in the right-of-way in which tree(s) are being planted. Iowa One Call will provide you with a locate number that shall be listed on the permit. This call is required for approval of the Street Tree Planting Permit. Once locates have been made, adjust your plans and re-stake tree locations as needed to avoid existing underground utilities.

2) Submit application: Scan and email the permit application to the Public Works Department – Operations Division's Arborist, Mike Stensrud, at mstensrud@ankenyiowa.gov. It can also be mailed or submitted to the attention of Mike Stensrud at the Public Works Maintenance Facility, 211 SE Lorenz Drive, Ankeny, Iowa 50021.

3) Approval by the City: The City will review the permit application and the staked locations at the property to verify compliance with applicable requirements. The applicant requesting the permit will be notified of approval or of any necessary changes needed to the permit. If the applicant is approved, then trees may be planted at that time.

4) Street Tree Maintenance: It is the duty of the property owner to prune, care for, and maintain any tree within the right-of-way that abuts their property. Tree branches shall be maintained so that the branches of the tree are at least fifteen (15) feet above the street and eight (8) feet above the surface of the sidewalk.
