C. PUBLIC HEARING(S):

1. **PH 2018-05:** SE East Lawn Area Utility Improvements - Phase 1 Project

Mayor Pro tem Holm opened the public hearing. Notice of this hearing was published in the Des Moines Register on the 19th day of January, 2018.

No written objections were filed and no oral objections were offered from the audience.

Mark Mueller, Public Works Director, reported this project includes the removal and replacement of PCC street pavement, sanitary sewer, water main and storm sewer generally located on SE Sherman Drive and on SE Peterson Drive from the intersection of SE Sherman Drive to just east of SE Sharon Drive in the City of Ankeny.

The bid opening for the project was held on Tuesday, January 30, 2018 at which six (6) bids were received with low bid submitted by MPS Engineers, PC dba Kingston Services, PC in the amount of \$981,563.00.

The engineer's estimate for the project was \$1,079,788.00. City staff reviewed the bid results internally and with the project's engineering consultant. MPS Engineers, PC dba Kingston Services, PC has completed projects of a similar nature for the City and they

have the experience to complete this project. It is recommended that the project be awarded to MPS Engineers, PC dba Kingston Services, PC.

This is the same zoning and use restrictions approved in 2012 and 2013 for the Toro and Chapman properties immediately to the east and south.
