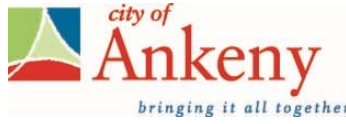

ADDITIONAL REQUIREMENTS PER THE ANKENY CITY CODE OF ORDINANCES:

(Please check the box if you certify the driver and vehicle complies with each of the requirements.)

1. **Chapter 134.03 (2.) Taxi Driver License**

a. Any person who applies for, or seeks to renew a Taxi Driver license must first obtain, at their own expense, his/her current DCI criminal history report, dated within one year of taxicab license application, through the state Department of Public Safety and a certified copy of his/her current driving record.

b. If a new applicant resided outside of the Iowa anytime during the five years before applying, the person must also obtain, at their own expense, a copy of his/her current criminal history report and certified copy of driving record from each state of residence during the prior five years. Any person whose taxi driver license has been suspended or revoked, or has expired for more than 30 days, will be required to obtain a current criminal history report and certified driving record in the same manner as a new applicant.

c. A list of all convictions (convicted of, pled guilty to or stipulated to the facts of a criminal offense) for criminal offenses, other than traffic offenses, during the ten years immediately preceding the date of application.

d. A list of all convictions for traffic violations for which the applicant's license was suspended, revoked or barred during the five years immediately preceding the date of application.

The State of Iowa Criminal Background Check form is available online at the Department of Criminal Investigation at <http://www.state.ia.us/government/dps.dci>, phone (515) 281-4776, Wallace State Office Building, Des Moines, Iowa. **Please note: the process to obtain these reports may take anywhere from one to six weeks.**

2. **Chapter 134.13 – VEHICLE CONDITION:**

a. Prior to use and operation, each vehicle must be made to comply with all applicable requirements of the State Motor Vehicle Code and other State and City laws.

b. Each vehicle operating under this chapter shall be kept in a clean and sanitary condition, both interior and exterior.

c. Each vehicle shall be equipped with an operable heater and air conditioner of adequate capacity.

d. Each vehicle exterior shall be maintained in good condition, with all parts intact and properly painted.

e. Each vehicle shall be in excellent mechanical condition, free from all known defects which could cause inconvenience or hazard to any passenger.

f. Each vehicle shall have properly inflated tires with a safe amount of remaining tread.

3. **Chapter 134.14 – PAINTING OF NAME REQUIRED:** Every taxicab licensed under the provisions of this chapter shall have the name of the licensee thereof plainly painted in letters at least one and one-half inches in height in the center of the main panel of each rear or front door of the vehicle, and shall be of a distinctive color scheme different from that of the licensed taxicab of any other owner.

4. **Chapter 134.15 – TAXIMETER REQUIRED:**

a. Every taxicab shall be equipped with a taximeter which shall comply with all State and Federal requirements relating to type and accuracy. For the purposes of this section, a "taximeter" means an instrument or device by which the charge for hire of a taxicab is mechanically calculated for distance traveled and waiting time, and within which such charge shall be indicated in terms of dollars and cents.

In lieu of imposing a fare based upon time and mileage, a licensee may impose a standard trip charge for transporting passengers for hire within certain geographical boundaries, or for travel to specific designations, provided that said licensee prominently displays such trip charges on the dashboard or other area which is plainly visible to a passenger.
