- Every permit shall expire twelve (12) months from the date of issue, unless the application is accompanied by a construction schedule of specific longer duration.
- It is the responsibility of the permittee to call for all inspections.
- No work shall be concealed or covered until approved by the inspector.
- Work that is not approved shall be considered incomplete.
- The permittee is assumed to be knowledgeable of the Code
- Questions should be resolved prior to installation.
- Permits are non-transferable - all work shall be performed by permittee or his/her employee.
